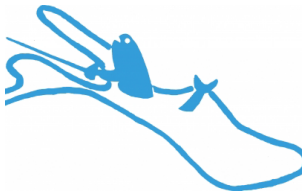
**Rules and legal** The event takes place according to FIE regulations.
