Rules for judges also apply to foreigners per nation: 4 fencers per nation 1 referee 8 fencers per nation 2 referees</p> <p>The judges must have at least a national license and an annual licence and be available for the entire duration of the event.</p> <p>We expect an adequate appearance: - trouser suit or skirt - suit and tie</p> <p>If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!</p>			<b>Entries ind.
