days before the start of the event; only vaccinations with vaccines are accepted,

which are approved in the EU (e.g. not Sputnik V or Sinovac); or

- have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months

than six months ago - if the infection occurred more than six months ago, they must provide evidence of a

provide evidence of a single vaccination;

- have a negative test for corona virus, provided that a certified rapid antigen test

antigen rapid test is not older than 24 hours and a PCR test is not older than 48 hours.
