**Jurisdiction** All participants are responsible for their own equipment.

**Medical** A healthcare professional (trained in first aid, cardiovascular/pulmonary rescue and sports injuries) must be present at the competition venue. A special place for the competition's medical care function should be visible to all participants and clearly shown.
