Format Combat mode according to the latest F.I.E. regulations
 There is no call. The athletes have to be on the piste 10 minutes before the start.
 First Round: (8 pools by 7 fencers = 56).
 The best 16 fencers present in the current DFB ranking are relieved. When setting the First rounds club affiliation is considered. 48 qualifiers to overall index. For index equality decides the better place in the respective DFB ranking, in uninitiated the lot.
 Direct elimination 64 without repechage (16 set + 48 qualifiers = 64), set according to entry index after First round or DFB ranking list for laws. Club affiliation is not considered. The placement of the liberated 16 fencers are dealt lot by steps of 2 (1-2, 3-4, 5-6, and so on until 15-16).
 8th finale: 3rd place will not be fought.
 Mode changes depending on the number of participants are possible and will be decided by the Technical Directorate on site.
 Team:
 The teams are placed according to the ranking of the recalculated ranking after the individual



competition.

The German Team Championships will be fought in the same mode as the World Championships. Direct elimination with fencing of places (possibly lack of participants an incomplete 16-tableau). Seeding according to the initial index. The placement of the team, from place 5-till the end, are done by drawing lot by steps of 2 (5-6, 7-8, and so on until the end).

The team matches are fenced in the relay mode according to the F.I.E. regulations.

The final time depends on the number of participating teams.

Rules and legal

The event takes place according to FIE and DFB regulations.

Liability

Organizer assume no liability. All participants are for responsible for the personal equipment.

Jurisdiction

The participants submit to the jurisdiction of the German Fencing Association e.V.

Anti Doping

Doping controls are planned.

Image / TV rights

TV, internet and radio rights to Germany's Active World Cups and German Active Championships have been transferred to Sport A (sports rights dealer of ARD & ZDF). A use of the rights is thus permitted only the public broadcasting corporations in Germany. These must be granted access to the competition sites. Any other right of use (eg use by other TV or radio stations or the organizing association and playback via Facebook, Twitter, etc.) must be brought about 4 weeks before the event on the partner Fechtsport Marketing GmbH (marketing agency of the Association) and is otherwise not given.

The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

The name imprint (on fencing jackets or e-vests) is mandatory at all Q-tournaments of the DFB in the U20 and seniors (according to Sports Committee, 04.07.09). It must be ensured that the name imprint also corresponds to the name according to the inscription and fencing pass.
