Rules and legal	The event takes place according to FIE and DFB regulations. In addition: The fencers can only start in the age group they belong to. If less than 6 fencers compete in an age group, they must be in the next younger or older age group compete separately. Multiple start is possible.
Liability	Organizer assume no liability. All participants are for responsible for the personal equipment.
Jurisdiction	The participants submit to the jurisdiction of the German Fencing Federation e.V.
Anti Doping	Doping controls may be carried out. The DFB / Organizer is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.
Image / TV rights	The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.
Medical	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights.
