Remarks	If the participating clubs register the referees by the registration deadline and the referees are present on the tournament day, the entry fee will be reduced to 15 € according to the following key. 1 referee for 1-6 starters (per club) 2 referees for 7-13 starters (per club) 3 referees for 14-20 starters (per club) 4 referees for 21-27 starters (per club) 5 referees for 28-35 starters (per club) The referees have to be named with the registration. The referees must be available from the beginning to the end of the tournament day. The strike date for referees is always 45 minutes before the start of the competition. (If the referee is not present, the full entry fee is due).
