Image / TV rights		The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition/event data. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions/events. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

	The name imprint (on fencing jackets or e-vests) is mandatory at all Q-tournaments of the DFB in the U20 and seniors (according to Sports Committee, 04.07.09). It must be ensured that the name imprint also corresponds to the name according to the inscription and fencing pass.
Supplier	Equipment vendor Uhlmann will NOT be represented at the competition.

Catering	Cafeteria is done by a commercial food service.
Remarks	Judges are NOT provided by the organizer! Therefore, compulsory judges have to be provided.
	A test station for quick tests CoViD-19 quick tests is located at the hall.

In Munich, the authorities apply the 2G+ rule. The sports facility may therefore only be entered by persons who have been vaccinated or have recovered and also have a PoC rapid test not older than 24 hours or a PCR test not older than 48 hours. No self-tests will be accepted. Also gun control and passport acceptance can only be done with 2G+ proof.
