Judges not older than age of 60 years. Karis nicht älter als 60 Jahre.

The referees officiating at EFC U23 circuit should have DFB CN licence and an annual licence, good national or international level qualification and be aged minimum 18 and less than 60.

Criteria for initial ranking of fencers

1. FIE senior ranking (only those having points)
2. FIE U20 ranking 1-64
3. EFC U23 Circuit ranking
4. DFB Senior ranking

Depending on the No. of Participants and according to valid CoVid19 Rules, the organisation committee (DT) reserves it's rights to change the formula of the competition to keep in mind the actual development.

**Rules and legal** The competition is held on the basis of the rules and regulations of the FIE, the EFC and the DFB.

**Liability** Organizer assume no liability. All participants are responsible for the personal equipment.

**Jurisdiction** The participants submit to the jurisdiction of the FIE, EFC and the relevant national federation.

**Anti Doping** Doping controls will be carried out.  
The DFB / Organiser is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organiser is proven to have acted with intent or gross negligence.

**Image / TV rights** The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

**Medical** A doctor is present in the competition site.  
Only doctors are entitled according to the international statutes to grant medical breaks during the fights.

Before entering the competition venue, we will be inspected according to the DFB hygiene guideline of 01.09.2021. We ask you to arrive in good time, be prepared and observe all the necessary registrations and certificates. Please observe the minimum distance of 1.5 m when waiting in front of the inspection area. We ask everyone here for understanding and acceptance, if necessary delays may occur and a late start of the competition is possible.





Please pay special attention to the following criteria:

Only registered athletes, accredited coaches (if applicable) as well as the tournament staff (judges, competitors) are allowed to enter the competition sites.

(judges, competition managers, tournament directors, weapon guards, helpers of the organiser) may have access to the competition sites. The persons present are to be documented.

Please report the officials online.

!!! Spectators are not allowed. !!!

Access to the competition site will only be granted to persons who...

- have received their second vaccination (with Johnson & Johnson only one vaccination required) at least 14 days before the start of the event; only vaccinations with vaccines approved in the EU are recognised (e.g. not Sputnik V or Sinovac); or

- have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months previously - if the infection was more than six months ago, they must provide evidence of a single vaccination;

- have a negative test for the Corona virus, whereby a certified rapid antigen test must not be older than 24 hours and a PCR test must not be older than 48 hours. The relevant time is the start of the tournament as stated in the announcement.

All participants (referred not only to fencers) have to print, sign and bring to the competition "COVID-19 ACKNOWLEDGEMENT OF RISK AND RELEASE FROM LIABILITY"

The general hygiene rules continue to apply at the competition venues. In particular, masks must be worn. The masks must correspond to the protection class specified by the federal state.

**Directions**

Actually in Bavaria the "2G" Rule is valid. All entries (Participants, Coaches, Accompanies) must have a vaccination with according to the EU Rules accepted Vaccination (for example Biontec, Johnson&Johnson etc. but for example no Sputnik), minimum 14 days before the event or an document of convalescence - not older than 6 month - in english or french. Additionally an actual Covid-19 Test not older than 24h could be required. Please check the actual rules directly before travelling.

External Visitors are not allowed to enter the venue. All Participants (Fencers, Referees, Coaches, Companions, Orga-Team, Stuff etc.) must register in time in the entrance portal. Without accreditation - to be presented at the check-in - entrance is not possible.
