**Jurisdiction** The participants submit to the jurisdiction of the German Fencing Federation e.V.

**Anti Doping** Doping controls may be carried out.  
The participants submit to the jurisdiction of the NADA.  
The DFB / Organizer is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.

**Image / TV rights** The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

**Medical** A doctor is present in the competition site.  
Only doctors are entitled according to the international statutes to grant medical breaks during the fights.

PLEASE NOTE THE CORONA RULES

Due to the currently ongoing Corona pandemic, the official Corona rules at the venue must be observed. There is a possibility that due to regional regulations no spectators and only limited attendants can be admitted and that only persons who are vaccinated or recovered can be admitted.

All participants are obliged to follow and observe even last-minute changes. No claim for damages against the DFB can be derived from the fact that an athlete or other participant cannot take part due to the Corona regulations applicable on site.

Should stricter regulations apply by the authorities, the state regulations shall take precedence.
