- 1) After the registration deadline (23.59 clock server time) no more entries can be entered into the system.
- 2) The pools (including the replacement fencers to complete the pools) will be published on Wednesday before the start of the competition from 15 clock on www.fencingworldwide.com. The entries must correspond to a realistic participation! Short-term scratch - with or without a certificate - is only possible until the pools are set. Then in any case (also with a certificate) to pay the entry fee and in case of non-occurrence without cancellation / attest additionally the fine of 300 EUR.
- 3) The pools are binding. Short-term scratches can not be compensated by additional replacement.

For the determination of the compulsory judges, the status quo Monday night is binding before the German Championships. Number of referees in the individual will be determined / calculated according to the calculation of the participants on Monday with followers and will also exist in case of cancellation, even with a medical certificate. The team also fixes the referees as of Monday after refilling. (Sportcommittee 6/2019)

The judges must have at least the required license and an annual licence and be available for the entire duration of the event.

Format Singles:
Combat Mode according to current F.I.E. Regulations.
There is no call! The athletes must be on the piste 10 minutes before the start.

First Round: (8 pools by 7 fencers = 56). The best 16 fencers present in the current DFB standings are relieved. When setting the preliminary rounds club membership is respected. 48 qualifiers to overall index. For index equality decides the better place in the respective DFB ranking, in uninitiated the lot.

Direct elimination 64 without repechage
(16 set + 48 qualifiers = 64), seeding according to entry index after First round or DFB ranking list for set. Club affiliation is not considered. The placements of the liberated 16 fencers will be solved in two-steps (1-2, 3-4, 5-6, and so on until 15-16).

8th finale: 3rd place will not be fought.

Team:

The German Team Championships will be seeded by the individual german ranking list, refreshed after the german individual championships. Maximum 24 teams can participate.

Direct elimination with fencing of all places.

The team matches are fenced in the relay mode according to the F.I.E. regulations.

The final time depends on the number of participating teams.

Rules and legal The event takes place according to FIE and DFB regulations.

Liability Organizer assume no liability. All participants are for responsible for the personal equipment.

Jurisdiction The participants submit to the jurisdiction of the German Fencing Federation e.V.

Anti Doping Doping controls are planned.
The participants submit to the jurisdiction of the NADA.

The DFB / Organiser is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.

Image / TV rights TV, internet and radio rights to Germany's Active World Cups and German Active Championships have been transferred to Sport A (sports rights dealer of ARD & ZDF). A use of the rights is thus permitted only the public broadcasting corporations in Germany. These must be granted access to the competition sites. Any other right of use (eg use by other TV or radio stations or the organizing association and playback via Facebook, Twitter, etc.) must be brought about 4 weeks before the event on the partner Fechtsport Marketing GmbH (marketing agency of the Association) and is otherwise not given.

The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

Medical A doctor is present in the competition site.
Only doctors are entitled according to the international statutes to grant medical breaks during the fights.

Before entering the competition venue, we will be inspected according to the DFB hygiene



guideline of 01.09.2021. We ask you to arrive in good time, be prepared and observe all the necessary registrations and certificates. Please observe the minimum distance of 1.5 m when waiting in front of the inspection area. We ask everyone here for understanding and acceptance, if necessary delays may occur and a late start of the competition is possible.

Please pay special attention to the following criteria:
Only registered athletes, accredited coaches (if applicable) as well as the tournament staff (judges, competitors) are allowed to enter the competition sites.
(judges, competition managers, tournament directors, weapon guards, helpers of the organiser) may have access to the competition sites. The persons present are to be documented.

Please report the officials online, the quota of officials is valid for each club.

- for 1-3 fencers per club: 1 coach
- for 4-6 fencers per club: 2 coaches
- for 7-10 fencers per club: 3 coaches
- more than 10 fencers per club: 4 coaches

!!! Spectators are not allowed. !!!

Access to the competition site will only be granted to persons who...

- have received their second vaccination (with Johnson & Johnson only one vaccination required) at least 14 days before the start of the event; only vaccinations with vaccines approved in the EU are recognised (e.g. not Sputnik V or Sinovac); or
- have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months previously - if the infection was more than six months ago, they must provide evidence of a single vaccination.
- have a negative test for the Corona virus, whereby a certified rapid antigen test must not be older than 24 hours and a PCR test must not be older than 48 hours. The relevant time is the start of the tournament as stated in the announcement.

The general hygiene rules continue to apply at the competition venues. In particular, masks must be worn. The masks must correspond to the protection class specified by the federal state.
