The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

Those present must be documented.  Insofar as the sports facility has a spectator area that is spatially separated from the competition venue in such a way is separated that a contact is not possible (also no direct accesses), so the organizer can Allow spectators in this area according to the regulations applicable in the respective federal state. However, contact between spectators and athletes is also allowed in the entrance area and during the entire competition event will not be given.  (2) An accreditation must be in accordance with the hygiene guideline of the DFB (see version of 1.9.2021) follow.  (3) Access to the competition venue shall only be granted to persons who... their second vaccination (only one-time vaccination required for Johnson &amp; Johnson) at least 14 days before the start of the event, or who have recovered from a proven COVID-19 infection, provided that the infection does not exceed six months ago. If the infection was more than six months ago, they must have a one-time Prove vaccination. have a negative test for the coronavirus, where a certified rapid antigen test must not be older than 24 hours and a PCR test must not be older than 48 hours. The relevant date is the start of the tournament specified in the announcement. If state regulations provide for 2G, this is a priority and thus excludes unvaccinated or unvaccinated people. Non-convalescent from entering the competition venue.  (4) Proof of vaccination can be provided by the vaccination certificate of a member state of the European Union or the European Vaccination Certificate in writing or electronically. The negative test is due to an official certificate from a test site or school Prove. The mere presentation of a student ID card is not sufficient. Other evidence includes: not allowed. Especially for pupils, because of the different regulations and holidays in the countries are not made an exception to the presentation of a test certificate. All Evidence must be checked by the organizer upon admission.

(5) If a competition lasts for several days of competition, a renewed Certificate can be submitted.

(6) Persons who are ill with Corona or are in officially ordered quarantine may: do not enter the competition venue.

(7) The general hygiene rules continue to apply at the competition venues. In particular, masks must waft. The masks must be of protection class (FFP2 or medical mouth-nose protection) , which is prescribed by the federal state in which the tournament is held. On the part of the DFB, the wearing of an FFP2 mask is recommended, as this is recommended in all federal states is recognised.

If an adequate mask is not carried, access to the competition venue can be and participation in the tournament is prohibited.
