The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

Only athletes, accredited coaches and staff of the organizers are admitted to the competition. Spectators are not allowed to enter the event. All persons entering the site must be registered in the registration system before the registration deadline. Unregistered persons will not have access to the competition site.

The number of officials admitted to the tournament per club is quoted:

- 1 to 3 fencers: 1 coach/official
- 4 to 6 fencers: 2 coach/official
- 7 and more fencers: 3 coaches/officials

THE COMPETITION WILL BE RUN AS A 2G EVENT. Only persons will be allowed to the event who

- \* have received their second vaccination (only one vaccination required at Johnson & Johnson) at least 14 days before the start of the event, or
- \* who have recovered from a proven COVID-19 infection, provided that the infection was not more than six months ago. If the infection was more than six months ago, they need to prove a single vaccination.

Exception: Persons of less than 16 years of age may also present a negative test for the corona virus, either a certified rapid antigen test not older than 24 hours, or a PCR test not older than 48 hours with respect to the the start of the tournament as specified in the invitation.

Persons who are infected with Corona or who are in officially ordered quarantine are not allowed to enter the venue.

Evidence of vaccination can be provided digitally or in paper by means of the vaccination certificate of a member state of the European Union or the European vaccination certificate. Recovery from an infection must be proven by an adequate certificate (e.g. official letter). The negative test of persons of less than 16 years of age must be proven by an official certificate from a test center. No other evidence is permitted. It is not sufficient to present a student ID. In particular, there is no exception for students from submitting a test certificate.

The general hygienic rules apply at the venue. In particular, all persons who do not directly participate in sport or who are not just recovering must wear face masks (protection class FFP2 or medical mouth and nose protection).

Due to the current circumstances, no cafeteria will be offered at the tournament. All athletes and coaches are kindly asked to provide for themselves.

If necessary, the medical regulations will be adjusted in the tender. All participants and supervisors are asked to check for the current rules shortly before the tournament.
