12 athletes of each nation, 20 home country athletes A valid FIE licence is required for the actual season.

No fencer is allowed to take part in an official event of the FIE until he or she has reached their 13th brithday.

The entry of the names of the fencers and all possible replacements, and the entry of teams, must be made via the FIE website 7 days before the competition at the latest (midnight Lausanne time). For team entries, the names of the fencers making up the teams may be changed, by informing the organisers, up to the day before the competition, at the latest at the end of the quarter finals of the individual competition. However, a replacement can be made after this stage, and at the latest at the end of the individual event, in the case of injury or illness duly certified by the competition medical doctor.

A valid DFB fencing pass is a starting requirement for German fencers. Adolescents under the age of 18 need a health certificate (not older than 365 days).

**Quota** The ranking position determines the participation.

**Referees** Referees are not required.
