Access to the competition site will only be granted to persons who have.... - have received their second vaccination (with Johnson &amp; Johnson only one vaccination required) at least 14 days before the start of the event; only vaccinations with vaccines are accepted, which are approved in the EU (e.g. not Sputnik V or Sinovac); or - have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months than six months ago - if the infection occurred more than three months ago, they must provide evidence of a provide evidence of a single vaccination; - have a negative test for corona virus, provided that a certified rapid antigen test antigen rapid test must not be older than 24 hours and a PCR test must not be older than 48 hours. . The relevant time is the start of the tournament specified in the announcement. The general hygiene rules continue to apply at the competition venues. In particular Masks must be worn. The masks must correspond to the protection class specified by the federal state correspond.</p>
