In case of no show, the relative clubs will have to pay the penalty fee payable in case of missing referee.</p> <p>All referees have to keep themselves available for the whole competition day.</p> <p>All referees are payed 50 € (regional referees and higher) and 25 € (module 1 beginner referees). The paiement is done cashless.
