The number of participants is unlimited. A valid FIE licence is required for the actual season.

No fencer is allowed to take part in an official event of the FIE until he or she has reached their 13th brithday.

The entry of the names of the fencers and all possible replacements, and the entry of teams, must be made via the FIE website 7 days before the competition at the latest (midnight Lausanne time). For team entries, the names of the fencers making up the teams may be changed, by informing the organisers, up to the day before the competition, at the latest at the end of the quarter finals of the individual competition. However, a replacement can be made after this stage, and at the latest at the end of the individual event, in the case of injury or illness duly certified by the competition medical doctor.

A valid DFB fencing pass is a starting requirement for German fencers. Adolescents under the age of 18 need a health certificate (not older than 365 days).

Following the rules of the German government, the government of the state Baden Württemberg, the

county Main-Tauber, the city of Tauberbischofsheim and applying the "FIE outline risk mitigation COVOD-19" guidelines of the FIE the following protocol is in place:

1) Entering Germany: Please refer to the actual regulations of the German government which can be

found here:

2) Registration to the competition: Every participant must undergo a RAT (rapid antigen test) after arrival and again four days after arrival. This operation is subsidized by the FIE. The tests are free to athletes, coaches, officials and referees. People with a negative test result will receive a bracelet as Identification after presentation of the negative test result. Only people with valid bracelet will be able to enter training and competition. Authorities will be able to control at any moment. 3) Departure tests: If you need a departure test (RAT 29 €, PCR 79 €) you will need to make a reservation by sending an e-mail with the required number of tests to worldcup@fechtentbb.de by 23.04.2022 at latest.

4) Positive testing: In case of a positive result by RAT a confirmation test by PCR will follow. The tested

person with positive RAT result must immediately go to his room and stay there under quarantine conditions until the PCR result is available.

The OC is required to transmit the full dataset of every person tested positive by PCR to the authorities. Legislation requires that persons tested positive have to be isolated immediately. The length of the isolation is regulated by the actual rules of the German government and will last seven days at minimum (status March 2022).

5) Form B and Form C of the FIE guideline (https://fie.org/fie/documents/other-documents) have to be completed and signed after the arrival in Germany. These documents have to be handed over to the organizers during accreditation.

6) Sanitary Measures according to the actual "FIE outline risk mitigation COVID-19" guideline.
