Format	According to the sports regulations of the fencing association of Niedersachsen: Seeding round (preliminary round), direct elimination with or without repechage, final. Depending on the number of teams registered, round system or direct elimination. Seeding after the addition of the places of the individual championship. The team competitions are held after the relaying system. The teams must be registered by name before the start of the individual finals.
Rules and legal	The event takes place according to FIE regulations.

Jurisdiction	The participants submit to the jurisdiction of the Fechtverband Niedersachsen e.V.
