<b>Format</b>	Everyone against everyone on 5 hits. Up to 13 participants we fence one big pool. If there are more than 13 participants, we fence 2-3 preliminary pools and based on that A, B and possibly also C finals. If there are more than 18 participants, the preliminary round will be fenced in fights to 3 hits in 2 minutes. The seeding of the pools will be done according to the current ranking list. The January tournament will be seeded according to the final standings of the previous year. Scoring will be based on wins and index. In case of index equality, the seeded hits count, if they are equal, the direct comparison counts.

Everyone will receive points according to their ranking! All fencers who did not participate will receive the score of the last place plus two points. THE ONE WHO HAS THE LEAST POINTS WINS!

Women and men are scored separately.

The participants submit to the jurisdiction of the Sächsischer Fechtverband e.V.
