<b>Catering</b>	Cafeteria is done by a commercial food service.
<b>Remarks</b>	<p>Covid-19 : In Bremen, the 2G rule applies to all sports participants and their accompanying persons from 14.02.2022.</p> <ul style="list-style-type: none"><li>- Fully vaccinated or recovered (date of collection of positive swab is at least 28 days, and maximum 90 days ago).</li></ul> <p>Exceptions:</p> <ul style="list-style-type: none"><li>- Children and adolescents up to 18 years of age. Students 16 and older still need proof that they are tested regularly at school.</li></ul> <p>When entering the premises of Bremen 1860:</p> <ul style="list-style-type: none"><li>- wear an FFP2 mask (children under 16 may wear a surgical mask).</li><li>- please show proof of vaccination or convalescence.</li><li>- It is mandatory to carry the vaccination or convalescent certificate and the identity card/passport, as these documents must be shown in the event of a control.</li></ul> <p>Contact details will no longer be collected.</p> <p>Spectators are restricted to the spectation areal and gain no access to the competition areal.</p> <p>Each club can accredit one coach/supervisor per three partaking athletes.</p> <ul style="list-style-type: none"><li>1-3 athletes: 1 coach</li><li>4-6 athletes: 2 coaches</li><li>9- athletes: 3 coaches</li></ul> <p>Only accredited athletes, coaches, referees and organisational personal gain access to the competition areal. These have to be registered in advance.</p>
