For the determination of the compulsory judges, the status quo Monday night is binding before the German Championships. Number of referees in the individual will be determined / calculated according to the calculation of the participants on Monday with followers and will also exist in case of cancellation, even with a medical certificate. The judges must have at least the required license and an annual licence and be available for the entire duration of the event.
