Criteria for initial ranking of fencers  
 1. FIE senior ranking (only those having points)  
 2. FIE U20 ranking 1-64  
 3. EFC U23 circuit ranking  
 4. DFB senior ranking  
 F.I.E. (Modified, ED without repechage)

<b>Rules and legal</b>	The competition is held on the basis of the rules and regulations of the FIE and the EFC.
<b>Liability</b>	Organizer assume no liability. All participants are responsible for the personal equipment.
<b>Jurisdiction</b>	The participants submit to the jurisdiction of the FIE, EFC and the relevant national federation.
<b>Anti Doping</b>	Doping controls will be carried out. The DFB / Organiser is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organiser is proven to have acted with intent or gross negligence.
<b>Image / TV rights</b>	The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.
<b>Medical</b>	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights.
