The referees must have at least a LFV license and an annual licence and be available for the entire duration of the event.

If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!
