**Catering** The Cafeteria is run by our club.

**Remarks** It is also possible to compete in the tournament without a referee. In this case, the "Referee surcharge" must be paid.

The "Referee surcharge" is also due if the participating clubs do not register any referees in accordance with the key by the registration deadline or the judges are not present on the day of the tournament.

The judges must be named with the entry form. Missing judges will be provided by the organiser. Therefore, judges who have not been registered but are brought along on the day of the competition cannot replace the surcharge for non-registered judges.

Referees will be reimbursed for their expenses in the form of vouchers for the cafeteria.

Participants from outside germany pay the entry fee and the Referee surcharge (if they have non referee) in cash at the competition.
