Instructions and regulations must be observed. <ul style="list-style-type: none"><li>•3G Rule: Judges/ Coaches/ Trainers/ Helpers from 17 years of age</li><li>• negative test proof: Sars-CoV2-Ag test valid for 24 hours</li></ul> Self-test possible on site under supervision (test must be brought along) <ul style="list-style-type: none"><li>• Compulsory school test for children under the age of 18: no proof required</li><li>• Children up to the age of 6 and children who have not yet started school, are not subject to testing</li><li>• Supervisor key (includes coaches, drivers, parents etc.; not judges):<ul style="list-style-type: none"><li>•1. Athletes: 1 supervisor</li><li>•from 4 athletes: 2 supervisors</li><li>•from 8 athletes applies: 1 supervisor for every 4 athletes</li></ul></li><li>• Only people without typical symptoms that indicate a SARS-CoV-2 infection are allowed to use the attend event</li><li>• Obligation to wear the prescribed medical mouth and nose protection in Indoor areas (excluding athletes in battle)</li></ul>
