All referees have to keep themselves available for the whole competition day.

1 team = 1 referee, 3 teams = 2 referees.

Referee meeting

All referees are paid 50 € (regional referees and higher) and 25 € (module 1 beginner referees).

The payment is done cashless. All referees have to bring their IBAN to the tournament. The payment is only done if the referee attends the referee meeting in the morning and stays available during the whole competition day for the tournament.
