The required number of qualified referees must be entered into the inscription system before athletes can be added to the competition.

The referees activity is not paid by the organizer.

Rules for judges also apply to foreigners per nation:

4 fencers per nation 1 referee

8 fencers per nation 2 referees

The judges must have at least a national license and an annual licence and be available for the entire duration of the event.

We expect an adequate appearance:

- trouser suit or skirt
- suit and tie

If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!

**Jurisdiction** The participants submit to the jurisdiction of the German Fencing Federation e.V.

**Anti Doping** Doping controls may be carried out.  
The participants submit to the jurisdiction of the NADA.  
The DFB / Organizer is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.

**Image / TV rights** The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition/event data. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions/events. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

**Medical** A doctor is present in the competition site.  
Only doctors are entitled according to the international statutes to grant medical breaks during the fights.
