This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the

possibility, but no obligation, to give the name.

**Medical** A doctor is present in the competition site.

Only doctors are entitled according to the international statutes to grant medical breaks during the

fights.
