<b>Remarks</b>	The entry fee for starters from the Berliner Fechterbund is 5,00 €. Late entries will have to pay the double entry fee. Missing passes will have to be compensated with 5,00 €. The gym may be entered only with sneakers. Referees from Berlin clubs will be compensated. Notice: The 12th Mini White Bear in foil U11/U12 will take place on the 24th of February 2019 in the context of the "Weißer Bär von Berlin". The referees are required all day on the respective competition day and are to be reported via the online registration system!!! Supervisors and athletes are only allowed to enter the hall with sports shoes!!!
