| Remarks | <p>The current version of the Corona Ordinance of the State of Rhineland-Palatinate in force on the day of the tournament as well as the hygiene concept of the organizer.</p> <p>Upon entry to the hall, the 2G status will be checked. (Minors are considered as "Equated persons" and do not need a 2G proof).</p> <p>In addition, ALL persons present at the event must pass a certified rapid test at the time of entry into the hall, which must be no more than 24 hours old. certified rapid test is required.</p> <p>In the hall masks are mandatory (FFP2 or comparable) except for the fencers in the fencing and in the preparation for it and for all present for the admission of food and drinks. and drinks.</p> <p>For coaches/supervisors and spectators/parents a quota regulation applies: For every 3 or part thereof starters per club, one coach/supervisor is allowed. Thereby only completely fencers, coaches, judges and officials registered via Ophardt will be admitted.</p> <p>Spectators/parents are only allowed to enter the stands and not the competition area.</p> | | |
