If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are

therefore considered for the calculation of compulsory judges to be sent!

imprint also corresponds to the name according to the inscription and fencing pass.
