The judges must have at least a national license and an annual licence and be available for the entire duration of the event.

- trouser suit or skirt
- suit and tie

If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!

The name imprint (on fencing jackets or e-vests) is mandatory at all Q-tournaments of the DFB in the U20 and seniors (according to Sports Committee, 04.07.09). It must be ensured that the name imprint also corresponds to the name according to the inscription and fencing pass.

Awards The award ceremony takes place during the final event. Places 1 - 3 receive pokes and money

prices (the first place - Euro 500,00; the second place - Euro 300,00 and the third place - Euro

100,00). All finalists (places 1 - 8) receive certificates.
