The tournament is a hobby fencing event. The fencers can be blind due to possible sun positions and the outdoor character. Tapings on parts of the fencing mask is allowed.

The tournament only takes place when the weather is stable. We inform on Friday, July 31. via eintracht-duisburg.org about the status. Transferred entry fees will be refunded by cancelation .

Due to the current legal regulations, only 30 people may take part in each competition. The hygiene concepts on site must be observed.

Participants are only allowed to enter the facility 30 minutes before the call. A long stay after the competition is not permitted.

Spectators and followers are not allowed on the venue. In the case of minors, an accompanying person is admitted as a spectator.

We ask everyone for understanding and keeping the distances. We look forward to getting back into the competition with you.
