 The required number of qualified referees must be entered into the inscription system before athletes can be added to the competition.
 The referees activity is not paid by the organizer.
 All referees must attend the referee meeting which will be hold 15 minutes before start of the first competition in the morning. In case of no show, the relative clubs will have to pay the penalty fee payable in case of missing referee.
 All referees have to keep themselves available for the whole competition day.
 All referees are payed 50 € (regional referees and higher) and 25 € (module 1 beginner referees).
 The paiement is done cashless. The paiement is only done if the referee attends the referee meeting in the morning and stays available during the whole competition day for the tournament.

U13 fencers and older are required to fence with the normal (long) weapon.
