There are primarily club teams eligible to start. For start groups the regulation of the DFB for start-up communities from July 2013 applies. Exceptions are regulated by the tournament management

Depending on the number of teams registered, round system or direct elimination. Seeding after the addition of the places of the individual championship. The team competitions are held after the relaying system. The teams must be registered by name before the start of the individual finals.		
<b>Rules and legal</b>	The event takes place according to FIE regulations.
