The team also fixes the referees as of Monday after refilling. For index equality, all fencers with same index are qualified for the DE. Direct elimination: Tableau 128, from Tableau 64 is fought until the finals of the top eight with repechage. The third place will not be fenced. Team: The German Team Championships will be seeded by the individual german ranking list. Maximum 24 teams can particpate. Direct elimination with fencing of all places. The team matches are fenced in the relay mode according to the F.I.E. regulations.
