Due to the increased organisational requirements of the corona, we reserve the right to cancel the event if the number of participants is too low. In order to have enough time to make this decision, the registration deadline has been brought forward considerably.

A cancellation at short notice due to a worsening of the pandemic is also possible.

The 3G RULE applies to all participants, including spectators and coaches, and a medical MOUTH-NOSE-PROTECION (MNP) must be worn at all times. The only exception is when the athletes are actively participating in sports.

ACCESS to the ARENA will only be granted to persons who either are

- are completly Corona vaccinated (14 days after the second vaccination) with proof through the vaccination certificate,
- are fully recovered from a Corona infection with medical proof, or
- have a Corona antigen test not more than 24 hours old or a PCR test not more than 48 hours old with negative results from an authorised testing centre; and
- have participated in the electronic data collection.
