Remarks	The number of people in the sports hall is limited by official requirements, so access is only permitted for accredited persons (fencers, trainers, referees, officials). Parents can stay outside the hall. The hygiene guidelines of the Bavarian Fencing Federation as well as the city of Nuremberg apply. U11, U13, U15 are pupils and need no test. U17 and above 3G rules apply, pupils with official school ID are excluded. Fencers U11 and U13 with no Trainer, one Parent is allowed on Tribune.
