 According to special regulations of the FBSH, U15 fencers are allowed to compete if they are ranked 1-4 in Schleswig-Holstein's U17 ranking list or have points in the German U17 ranking list. A valid DFB fencing pass is a starting requirement for German fencers. Adolescents under the age of 18 need a health certificate (not older than 365 days).  
 It is not permitted to participate on multiple competitions per competition day.  
 Only one entry per athlete for each category is allowed.

**Format** Two fencers (regardless of gender) form a team. Each team match consists of 4 bouts. In a match





between a lady and a man, only the lady's hit counts in case of a double. The team with the most individual victories wins the team match and gets 3 points. In the event of a tie, both teams get one point and the team with the better hit difference gets an additional point. In the event of tied points in the end of the tournament, the total hit difference decides. Whether every team fights against each other or it will be fenced in rounds depends on the number of participants.

**Rules and legal**

The event takes place according to FIE regulations.

Organizer assume no liability. All participants are for responsible for the personal equipment.

**Jurisdiction**

The participants submit to the jurisdiction of the Fechterbund Schleswig-Holstein e.V.
