The judges must have at least a national license and an annual licence and be available for the entire duration of the event.

- trouser suit or skirt
- suit and tie

If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!

prices (the first place - Euro 500,00; the second place - Euro 300,00 and the third place - Euro

100,00). All finalists (places 1 - 8) receive certificates.
