Format	Combat mode according to the latest F.I.E. regulations There is no call. The athletes have to be on the piste 10 minutes before the start. First Round: (8 pools by 7 fencers = 56). The best 16 fencers present in the current DFB ranking are relieved. When setting the First rounds club affiliation is considered. 48 qualifiers to overall index. For index equality decides the better place in the respective DFB ranking, in uninitiated the lot. Direct elimination 64 without repechage (16 set + 48 qualifiers = 64), set according to entry index after First round or DFB ranking list for laws. Club affiliation is not considered. The placement of the liberated 16 fencers are dealt lot by steps of 2 (1-2, 3-4, 5-6, and so on until 15-16). 8th finale: 3rd place will not be fought. Mode changes depending on the number of participants are possible and will be decided by the Technical Directorate on site. Team: The German Team Championships are seeded according to the respective individual ranking. A maximum of 24 teams can participate. Direct elimination with fencing of all places. There will be no ranking according to the same LFV. The team fights are carried out in relay mode according to F.I.E. regulations.
Rules and legal	The event takes place according to FIE and DFB regulations.
Liability	Organizer assume no liability. All participants are for responsible for the personal equipment.
Jurisdiction	The participants submit to the jurisdiction of the German Fencing Federation e.V.
Anti Doping	Doping controls are planned. The participants submit to the jurisdiction of the NADA.
	The DFB / Organiser is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.
Image / TV rights	TV, internet and radio rights to Germany's Active World Cups and German Active Championships have been transferred to Sport A (sports rights dealer of ARD & ZDF). A use of the rights is thus permitted only the public broadcasting corporations in Germany. These must be granted access to the competition sites. Any other right of use (eg use by other TV or radio stations or the organizing association and playback via Facebook, Twitter, etc.) must be brought about 4 weeks before the event on the partner Fechtsport Marketing GmbH (marketing agency of the Association) and is otherwise not given.
	The participants and their legal representatives declare that they agree to a publication of their





	names, clubs and year of birth as the as the competition data The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.
Medical	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights.

	The name imprint (on fencing jackets or e-vests) is mandatory at all Q-tournaments of the DFB in the U20 and seniors (according to Sports Committee, 04.07.09). It must be ensured that the name imprint also corresponds to the name according to the inscription and fencing pass.
Awards	Individual: Places 1-3 DFB championship medals Places 1-8 DFB championship certificates Team: Places 1-3 DFB championship medals The finalists wear promotional shirts of the title sponsor as part of the presentation and presentation ceremony. The wearing of private and / or club sponsors will of course remain unaffected.
