The name imprint (on fencing jackets or e-vests) is mandatory at all Q-tournaments of the DFB in the U20 and seniors (according to Sports Committee, 04.07.09). It must be ensured that the name imprint also corresponds to the name according to the inscription and fencing pass.

Awards

The award ceremony takes place during the final event. Places 1 - 3 receive pokes and money prices (the first place - Euro 500,00; the second place - Euro 300,00 and the third place - Euro 100,00). All finalists (places 1 - 8) receive certificates.
