A valid FIE licence is required for the actual season.

No fencer is allowed to take part in an official event of the FIE until he or she has reached their 13th brithday.

The entry of the names of the fencers and all possible replacements, and the entry of teams, must be made via the FIE website 7 days before the competition at the latest (midnight Lausanne time). For team entries, the names of the fencers making up the teams may be changed, by informing the organisers, up to the day before the competition, at the latest at the end of the quarter finals of the individual competition. However, a replacement can be made after this stage, and at the latest at the end of the individual event, in the case of injury or illness duly certified by the competition medical doctor.

A valid DFB fencing pass is a starting requirement for German fencers. Adolescents under the age of 18 need a health certificate (not older than 365 days).

Any other right of use (eg use by other TV or radio stations or the organizing association and playback via Facebook, Twitter, etc.) must be brought about 4 weeks before the event on the partner Fechtsport Marketing GmbH (marketing agency of the Association) and is

otherwise not given.

The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the

possibility, but no obligation, to give the name.
