	The judges must have at least a national license and an annual licence and be available for the entire duration of the event.

	If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!

temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

Only doctors are entitled according to the international statutes to grant medical breaks during the fights.
