All referees have to keep themselves available for the whole competition day.

All referees are payed 50 € (regional referees and higher) and 25 € (module 1 beginner referees).

The paiement is done cashless. All referees have to bring their IBAN to the tournament. The paiement is only done if the referee attends the referee meeting in the morning and stays available during the whole competition day for the tournament.

U13 fencers and older are required to fence with the normal (long) weapon.
